Regular Town Business:

1. Consideration to approve bills, as submitted by the Director of Finance.
2. Consideration to approve prepaid warrant as submitted by the Director of Finance.
3. Consideration to approve purchase orders as submitted by the Director of Finance.
4. Resolution to adopt the Town's revised Investment Policy as presented by the Director of Finance.
5. Resolution to close Capital Project H0236 Recreation Center Pickleball and Tennis Court Renovation and to transfer the balance of unspent funds \$986.35 to the Parkland Trust Fund.
6. Resolution for the Supervisor to sign a Professional Services Agreement with Pay Trac to provide credit card processing services for the Town of Webster Parks and Recreation Department.
