1. **HEGEDORN'S PLAZA REDEVELOPMENT:** Located at 964 Ridge Road. Applicant Matt Tomlinson of Marathon Engineering is requesting **FINAL SITE PLAN APPROVAL** associated with the proposed redevelopment of the former Hegadorn's Supermarket Plaza on a 6.68-acre parcel having SBL # 079.15-1-1.1 located in an HC High Intensity Commercial District under Section 269-11 of the Code of the Town of Webster
