

**RESOLUTION NO. \_\_\_\_ OF 2024 OF THE WEBSTER TOWN BOARD TO ESTABLISH  
A PRIVATLY OWNED HELIPORT AT 893 DEWITT ROAD, WEBSTER, NEW YORK**

At a regular meeting of the Webster Town Board of the Town of Webster, Monroe County, New York, held at the Town Board Meeting Room, 1002 Ridge Road, Webster, New York, on the 6<sup>th</sup> day of June 2024 at 7:30 p.m., there were present:

The following Resolution was offered by \_\_\_\_\_ and moved its adoption:

WHEREAS, John Casciani is the owner of that certain property located at 893 Dewitt Road, Webster, NY; and

WHEREAS, John Casciani has made application to the Town and requested approval and authorization from this Board pursuant to New York General Business Law Subsection 249 for the establishment of a privately-owned heliport to be located at 893 Dewitt Rd., Webster, New York; and

WHEREAS, New York General Business Law Subsection 249 provides that no person shall establish a privately-owned heliport except by authorization of the governing body of the Town in which said privately-owned heliport is proposed to be established; and

WHEREAS, New York General Business Law Section 249 further provides that the governing body of a Town shall not authorize the establishment of a privately-owned heliport unless said approval is in accordance with the standards prescribed by the Commissioner of Transportation of the State of New York; and

WHEREAS, the Federal Aviation Administration has reviewed the airspace surrounding 893 Dewitt Rd., Webster, NY and has issued a favorable airspace determination of said airspace and otherwise recognizes the property located at 893 Dewitt Rd., Webster, NY as a FAA approved privately-owned heliport facility; and

WHEREAS, the Commissioner of Transportation of the State of New York has confirmed that the establishment of the proposed privately-owned heliport complies with the Commissioner's standards as evidenced by the Certificate of Registration issued by the New York State Department of Transportation Aviation Bureau; and

WHEREAS, this matter now comes to be heard by this Board for authorization and approval in accordance with New York General Business Law Section 249:

**NOW, THEREFORE, BE IT RESOVLED:**

That the proposed privately-owned heliport located at 893 Dewitt Rd., Webster, NY complies with the standards adopted pursuant to New York State General Business Law Section 249 and is hereby authorized and approved by the Town of Webster.
