2025 Webster Budget Message

The Town of Webster commenced the 2025 budget season in early May. It's a process that takes six months of the year to complete and it demands a considerable effort by the Town department heads, the Director of Finance and the Town Board. Each department head was instructed to put forth their best effort to minimize the tax levy for the citizens, while providing for the needs within their respective departments. The department heads presented their budgets during the televised budget workshops that were held on August 1 and August 8. A public hearing on the 2025 Preliminary Budget will be held on October 17 at 7:30pm.

Since the Town's primary role is to provide services, employee compensation and benefits is the largest portion of the budget. It encompasses 56.8% of net expenditures. Total employee compensation for 2025 is \$16,377,353 versus \$15,374,552 for 2024. This represents a \$1,002,801 (6.5%) increase. At the time that the 2024 budget was completed the police union contract remained unsettled so the cost-of-living adjustment (COLA) increase was not built into each line item. Therefore the 2025 police budget reflects a jump for the COLA increase in 2024 and 2025, which was 3% and 4%, respectively. The 2025 budget also includes a \$85,000 police retention bonus which was not part of the 2024 budget. In addition, three new positions were added which include a communications assistant, a recreation leader and a maintenance mechanic in the sewer department.

The three positions have an aggregate compensation cost of \$147,037.

The employee benefits include contributions to the NYS retirement system, employers share of social security, worker's compensation insurance, medical and dental insurance, health savings account contributions and medical insurance paid on behalf of retired former employees. The budget for 2025 is \$8,407,000 versus \$8,126,800 for 2024. This represents a 3.5% increase.

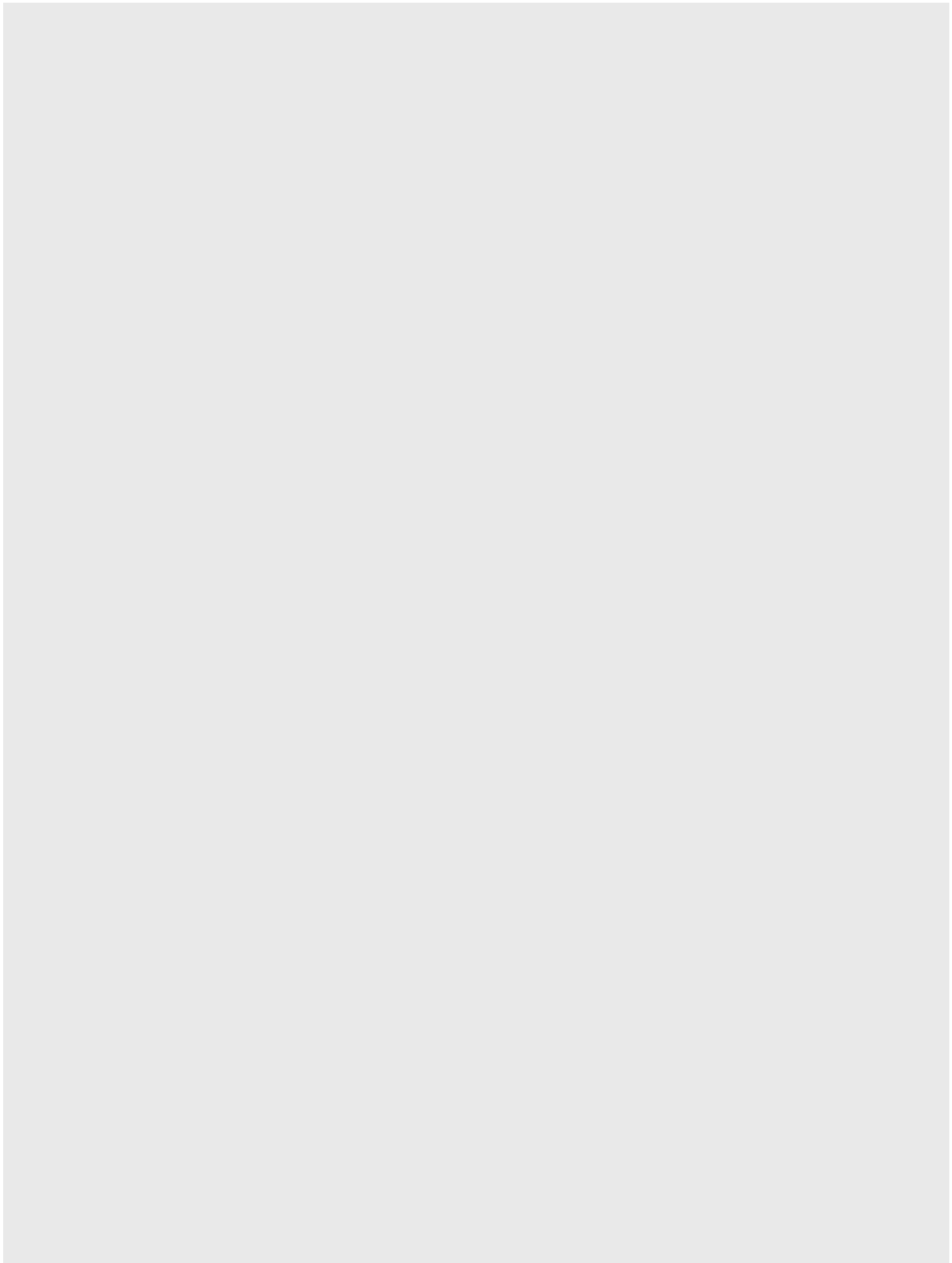

The 2024 budget includes a significant increase in debt service costs. In August of 2024 the Town renewed the 2023 bond anticipation note (BAN) and borrowed \$67,050,000 to fund the Highway Building project (\$22,100,000), Sandbar Park project (\$3,670,000), the Wastewater Treatment Plant Phase II project (\$35,000,000) and the Tebor to Phillips Road Conveyance Pipe project (\$6,280,000). The BAN is a one-year loan which is based on projected cash flow requirements for each project. The Town's BAN sale process proved to be very competitive which resulted in a \$681,964 premium paid to the Town

and a net interest rate of 2.936%. This was better than expected. When the BAN matures the premium will be recognized as revenue in 2025 which will partially offset the gross interest charge. The Town's debt service payments for 2024 will total \$5,953,138 versus \$4,450,356 for 2024. This represents a \$1,502,782 (33.8%) increase.

This budget includes increased revenue from commercial sewer charges and entrance fees. We have included \$2,986,550 for 2025 versus \$1,038,810 for 2024. The increase is primarily due to the Coca-Cola/fairlife® entrance fee which is being paid to the Town in annual installments of \$2,190,000 over ten years. A large portion of the Town's surplus fund balance (\$3,991,676) has been appropriated to stabilize the 2025 tax levy. The appropriation helps the Town stay in line with its' fund balance policy which has set limits on the amount of surplus that can be held.

Overall, the 2025 budget is fiscally sound in spite of persistent inflation and increased debt related to the various capital projects that are in process. The Town officials are working together to project the Town's financial position into the future so that revenue and expenses can be effectively managed beyond the one-year window of the budget process. We are pleased to say that the Town has been able to stay under the New York State tax cap, while continuing to provide the same level of service to the citizens.





2025 WEBSTER BUDGET

The Town of Webster’s annual budget process is robust. The Town strives to ensure services are being delivered to our community in a responsible manner. The 2025 budget underscores the Town of Webster’s commitment to **investing in infrastructure**, **supporting economic growth**, and **funding quality-of-life services** that truly make the Town of Webster a place where life is worth living, all while protecting Webster taxpayers.

Protecting Taxpayers

The Town of Webster works diligently to ensure that taxpayer dollars are being used responsibly to fund necessary expenditures and plan for the future. The 2025 budget protects taxpayers by remaining under the New York State tax cap.

There is a slight raise in the Town tax rate, with a net increase of \$0.34 from \$5.06 to \$5.40. Overall, the tax rate has remained relatively stable since 2020. Taxpayers will also see that there is a **decrease of \$43.90** in sewer rent charges, from \$296.83 to \$252.93.

As Supervisor Flaherty mentioned in his budget message, this means that the aggregate tax bill for an average house (assessed value of \$177,000) outside of the Village of Webster will increase 1.4%.

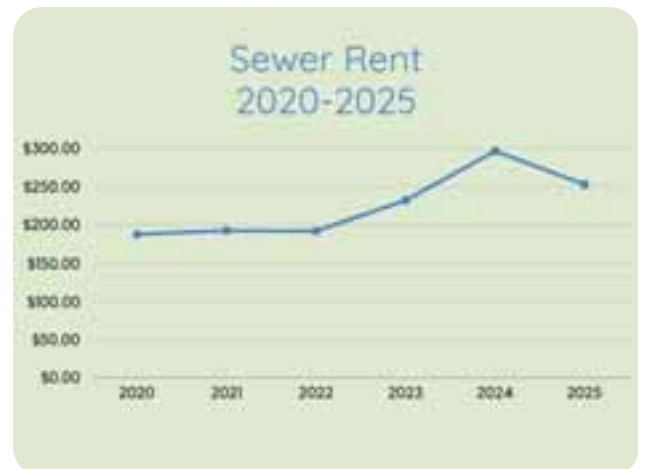
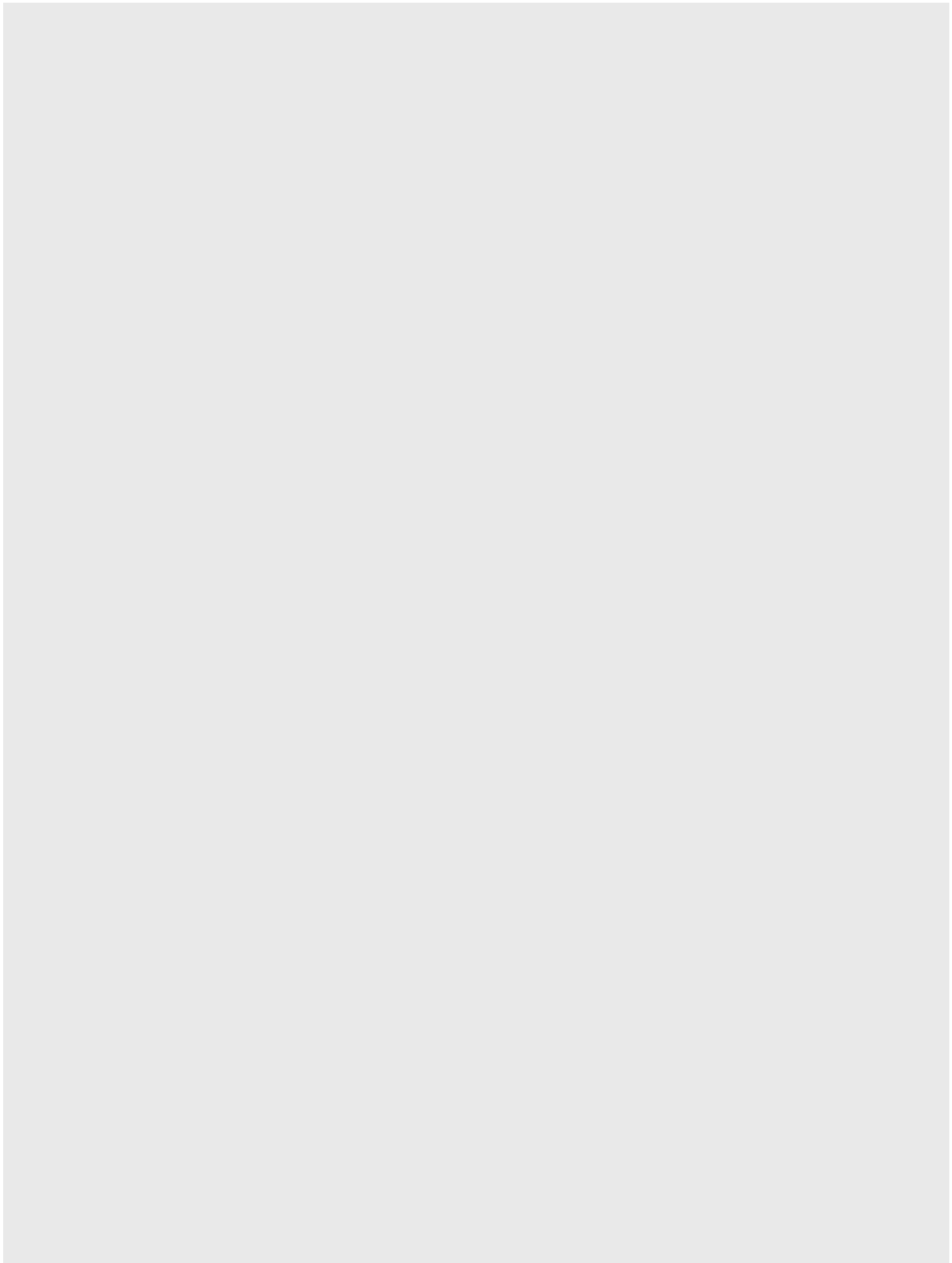


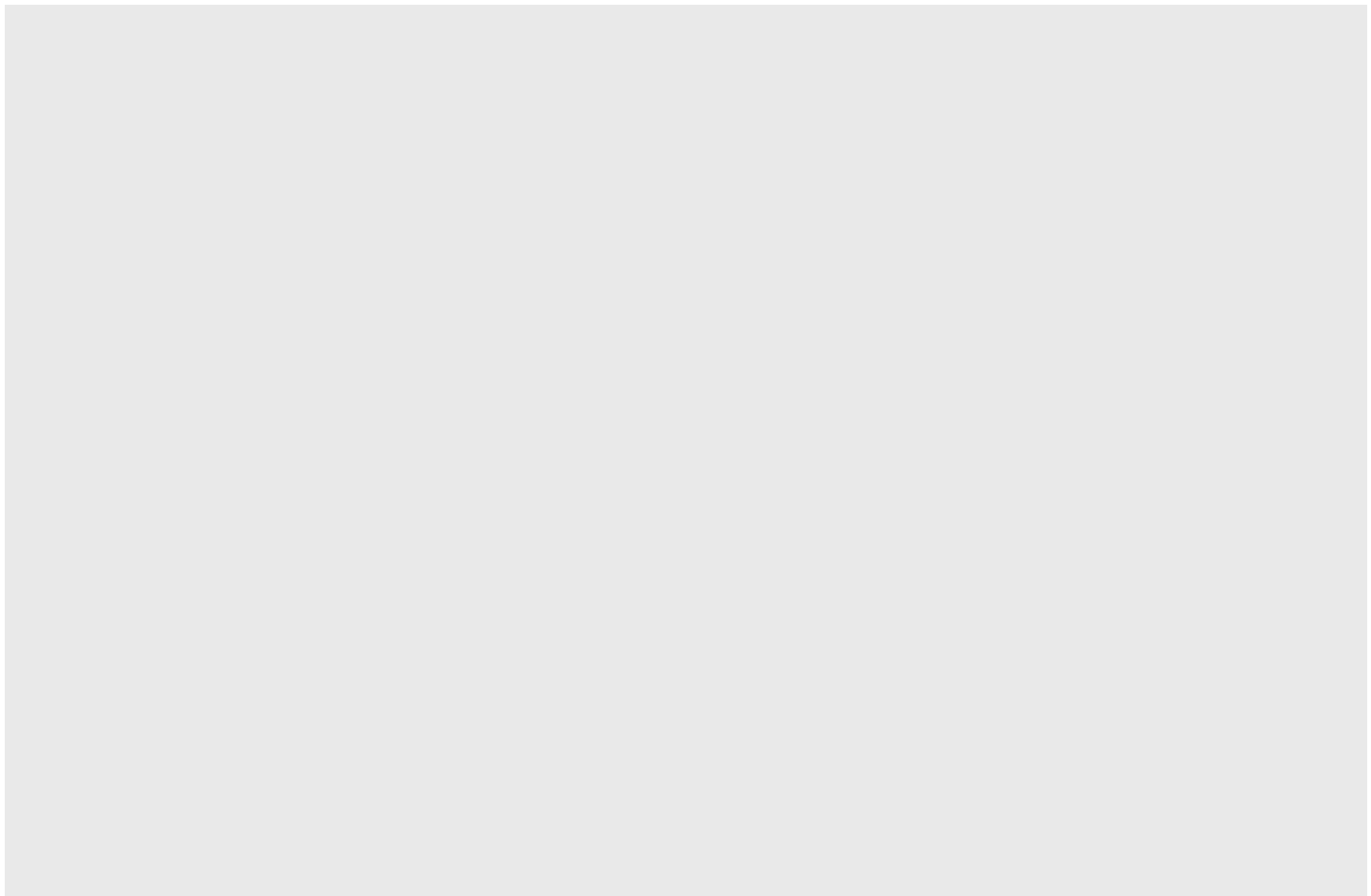
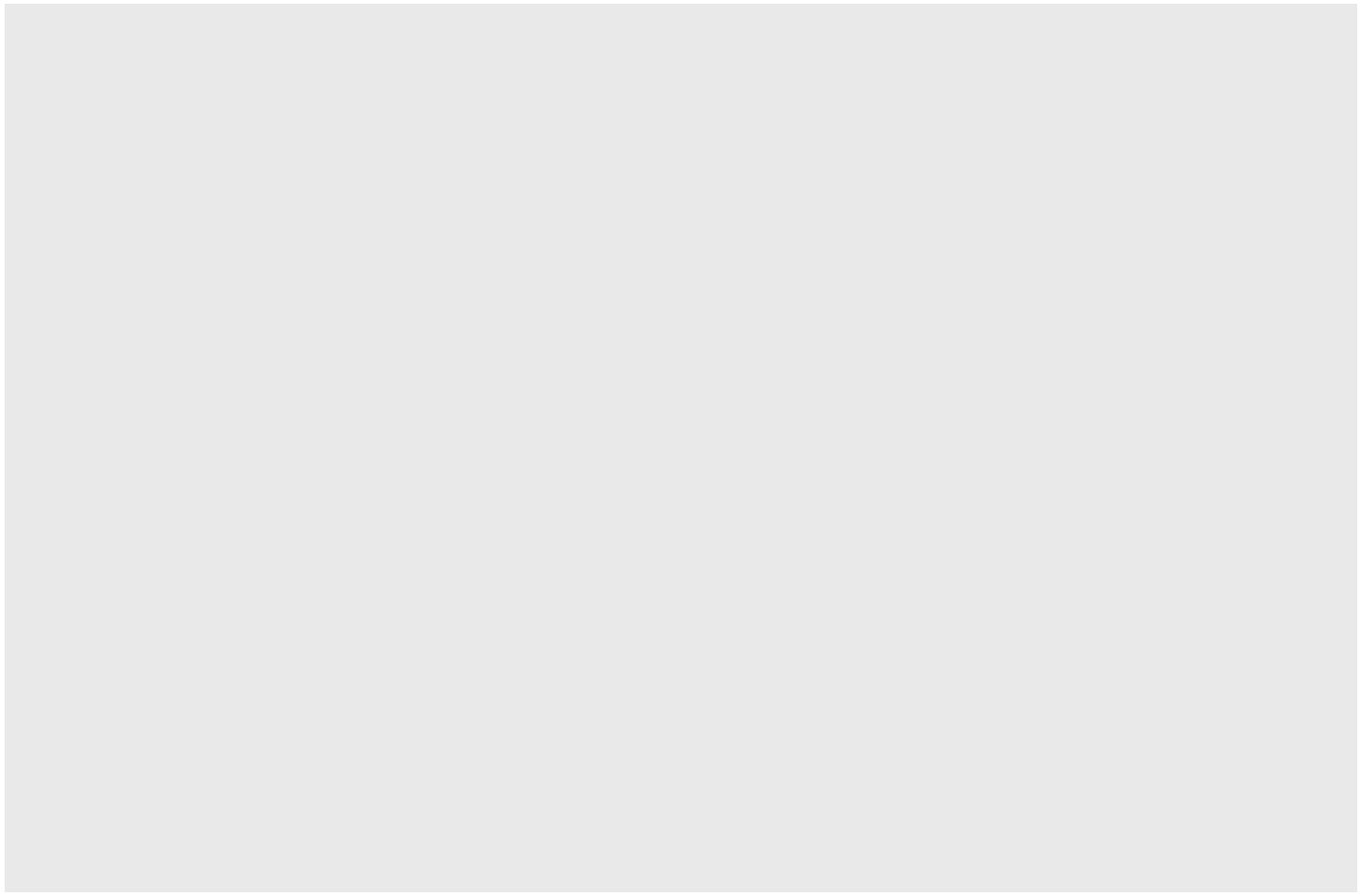
Fig. 2: Sewer rent charges will see a decrease of \$43.90 in 2025.

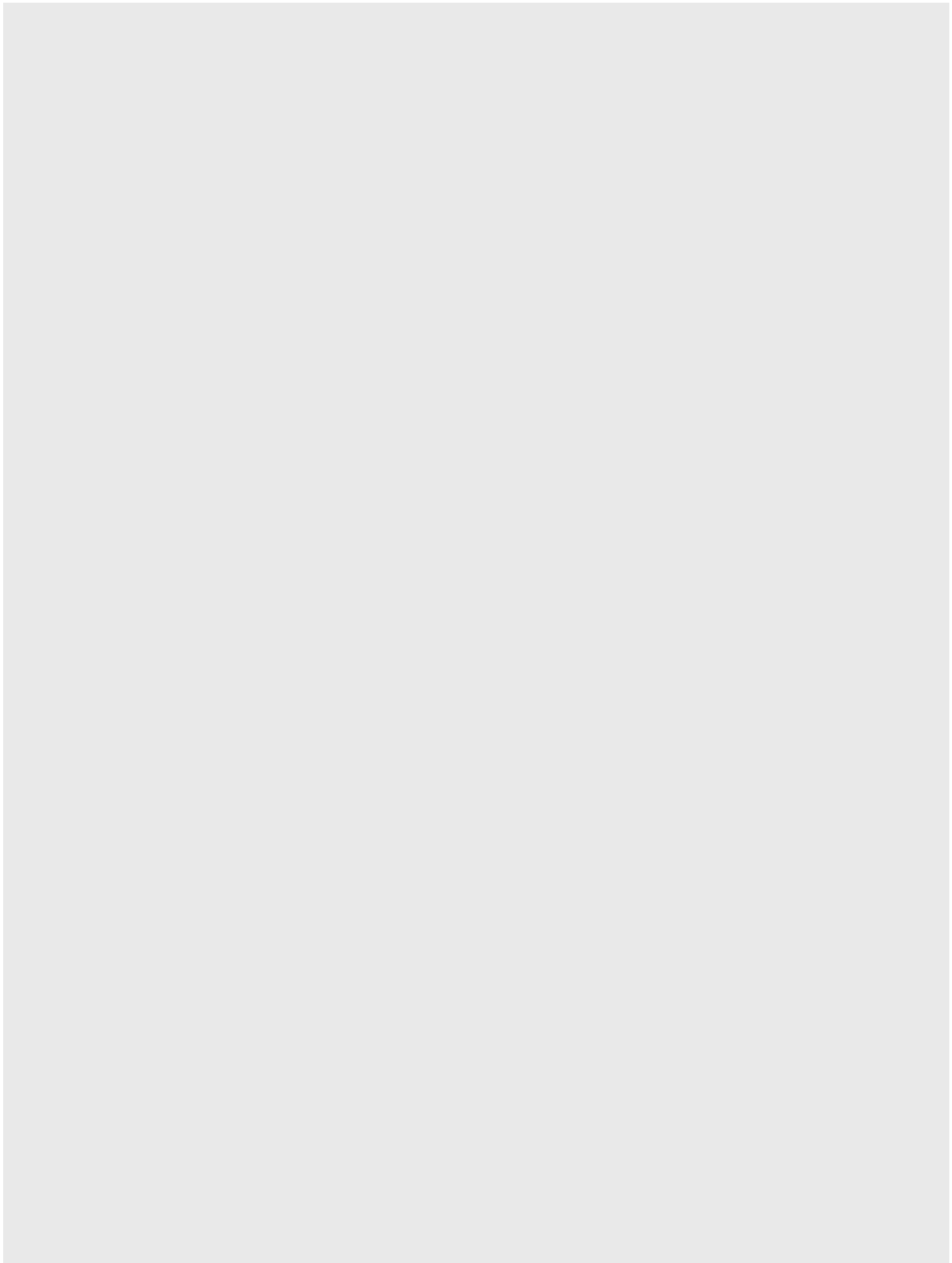




Fig. 4 (left): The Town of Webster’s anticipated major revenues for 2025.

Investing in Infrastructure

Timely investments in infrastructure equate to long-term cost savings. The 2025 budget contains significant investments in our Town in maintenance and improvements to our Wastewater Treatment Plant, provisions for equipment to maintain town roads, construction of the new highway building, and technology infrastructure to improve accessibility and reach.

The budget will support a network infrastructure update for all town facilities. After extensive research was conducted, it was determined that it is most practical to make these upgrades all at once rather than spread across several years.

The 2025 budget also includes an investment of \$540,000 into the Sewer Capital Reserve. This is significant, as this fund will support future sewer plant repairs and asset renewal.

Supporting Economic Growth

Economic growth and investing in our community continue to be a top priority for the Town of Webster. This can be seen in many aspects of our town government which is supported by the 2025 budget.

The upgrades to the Wastewater Treatment Plant

to transform it into a Water Resource Recovery Facility that will generate significant revenue in the future and have a substantial impact on taxpayers’ wallets. These upgrades also foster an environment that will continue to attract businesses to our community.

The 2025 budget also supports community planning initiatives like preparing 600 Ridge Road for sale and the update of the Town of Webster’s Comprehensive Plan. These planning initiatives are critical to establishing the vision for the future of Webster.

Funding Quality of Life Services

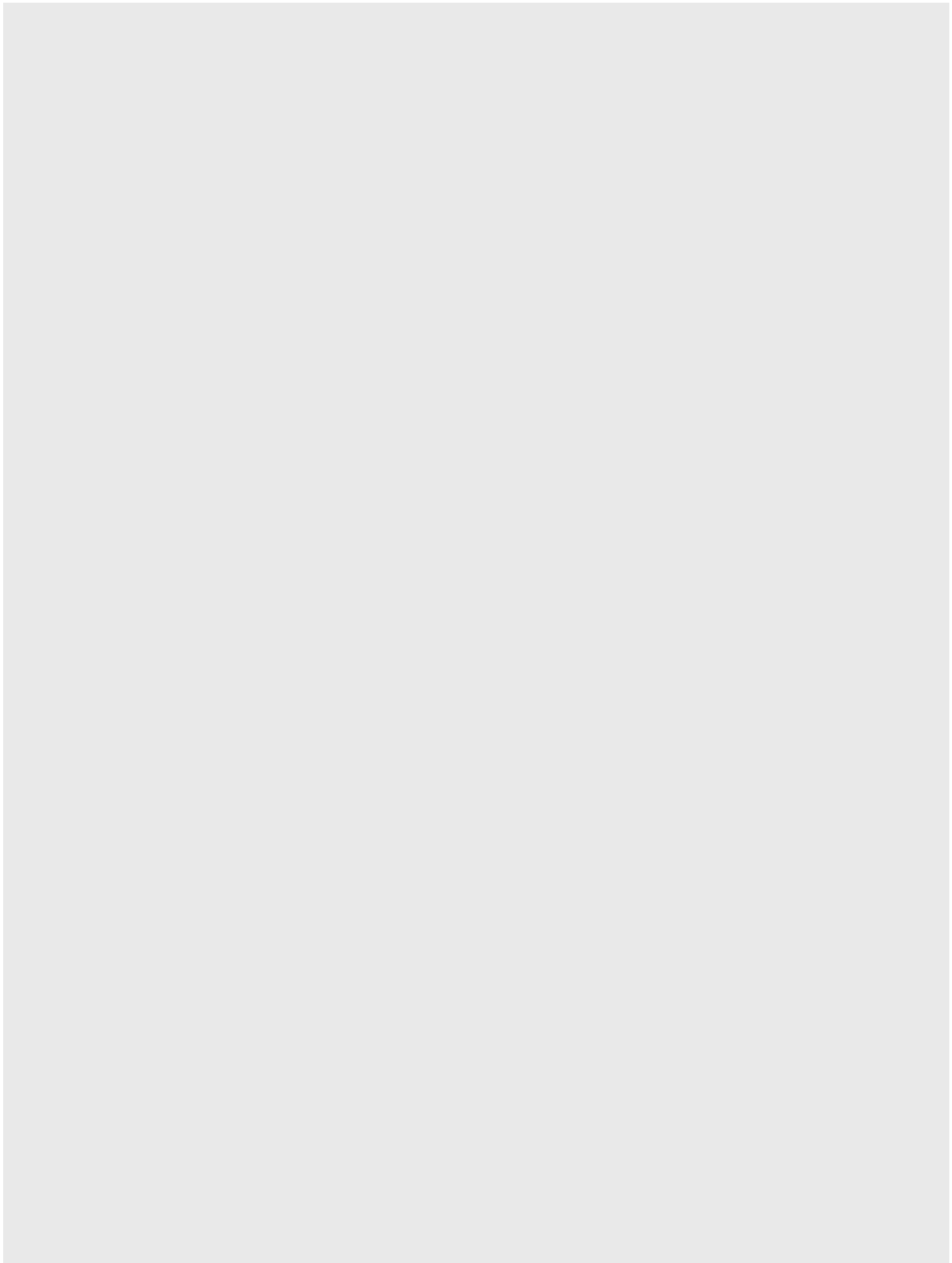

A VISION FOR THE FUTURE:

Webster's Comprehensive Plan

The Town of Webster is embarking on an update to its Comprehensive Plan. This plan will create a community-based vision for the future of our town and support a balanced economic and community development strategy based on current and projected market trends. The existing comprehensive plan was last updated in 2008. Having an up-to-date comprehensive plan is imperative to reaching long-term goals for our community.

What is a Comprehensive Plan?

A comprehensive plan expresses a community's long-term vision, goals, and objectives. Through establishing policies and strategies, comprehensive planning prioritizes capital improvement and infrastructure projects, informs land use regulations and local decision-making, and functions as the basis for updating the Town's Zoning Ordinance and Official Zoning Map. An update to the comprehensive plan will analyze population demographics, housing types and density, economic demographics, transportation, infrastructure, land use, culture and recreation,

sustainable practices, and environmental resources to develop policies, recommendations and strategies.

Benefits of an updated Comprehensive Plan

There are several benefits to having an up-to-date comprehensive plan. It provides municipal officials with an understanding of historical trends, present conditions, and an opportunity to thoughtfully plan for future growth. An updated comprehensive plan also assists in attracting grant funding for implementation of projects and initiatives identified in the plan. Another benefit of updating the Town of Webster's comprehensive plan is to ensure a balanced economic and community development strategy based on the community's physical, environmental, and social conditions.

Timeline, costs, and funding

In August, the Town issued a request for proposals (RFP) for professional consulting services to assist with this effort. Proposals were due on September 13th. An internal

committee comprised of Town staff is in the process of evaluating the proposals received and is expected to make a recommendation for selection to the Town Board in the coming weeks.

Next Steps

This community-driven initiative will include ample opportunities for public engagement throughout the process, including formation of several topic-based committees, public open house meetings, web-based surveys, presence at local community events, and venues and other mechanisms to ensure that a wide cross-section of our community is represented. Stay tuned to the Town's website, newsletters and social media channels in the coming months for opportunities to get involved in the process.

As the updated comprehensive plan will be a blueprint for our community and a template for achieving long-term objectives that align with the needs, behaviors, and vision of our community, we look forward to engaging with you as this important project moves forward!

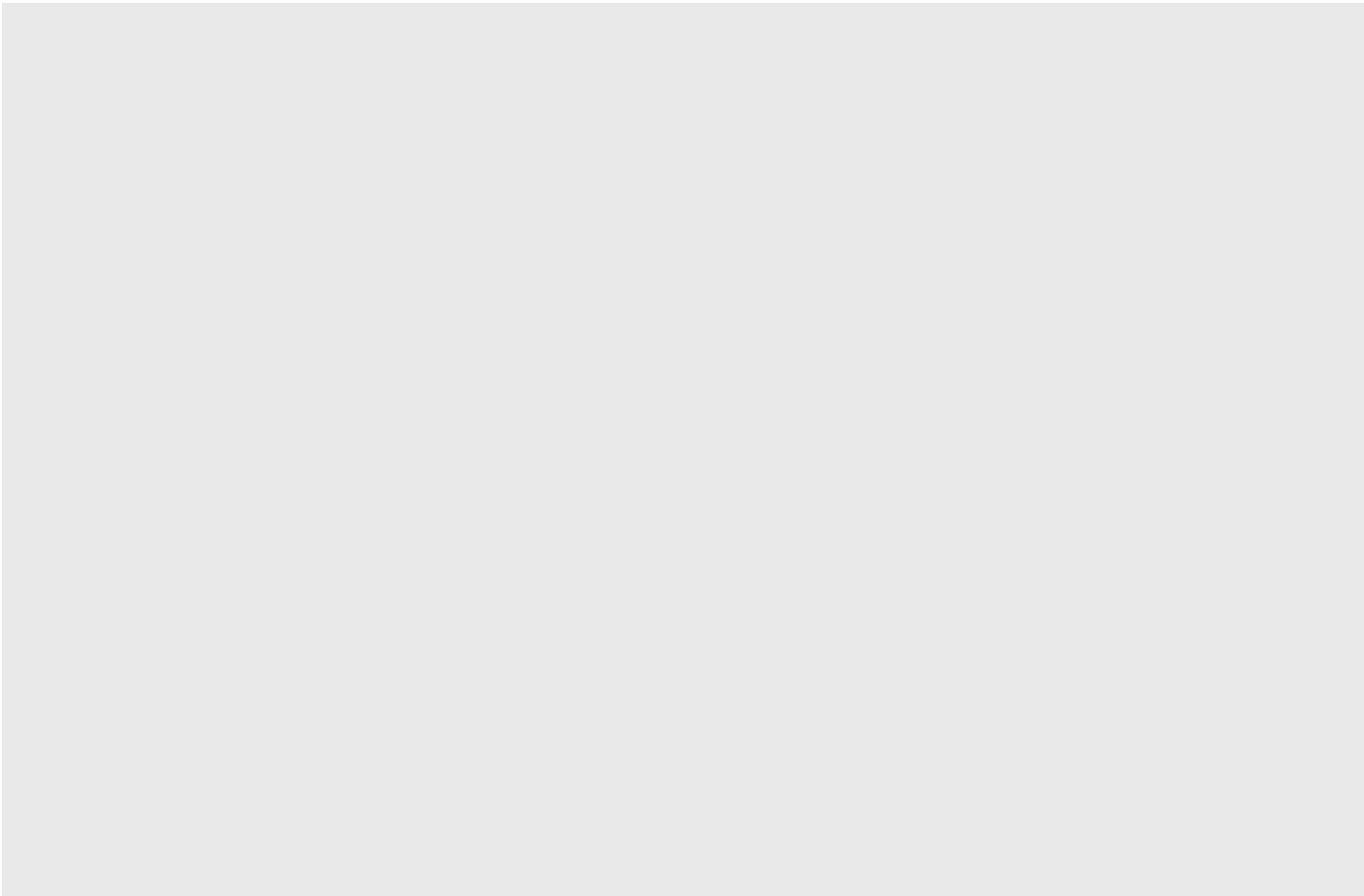
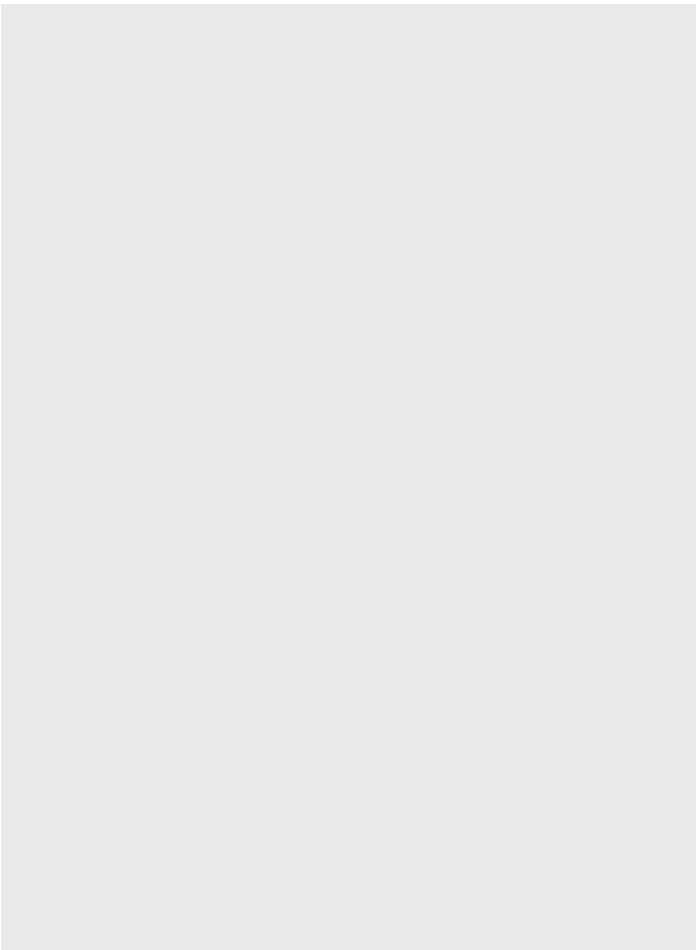
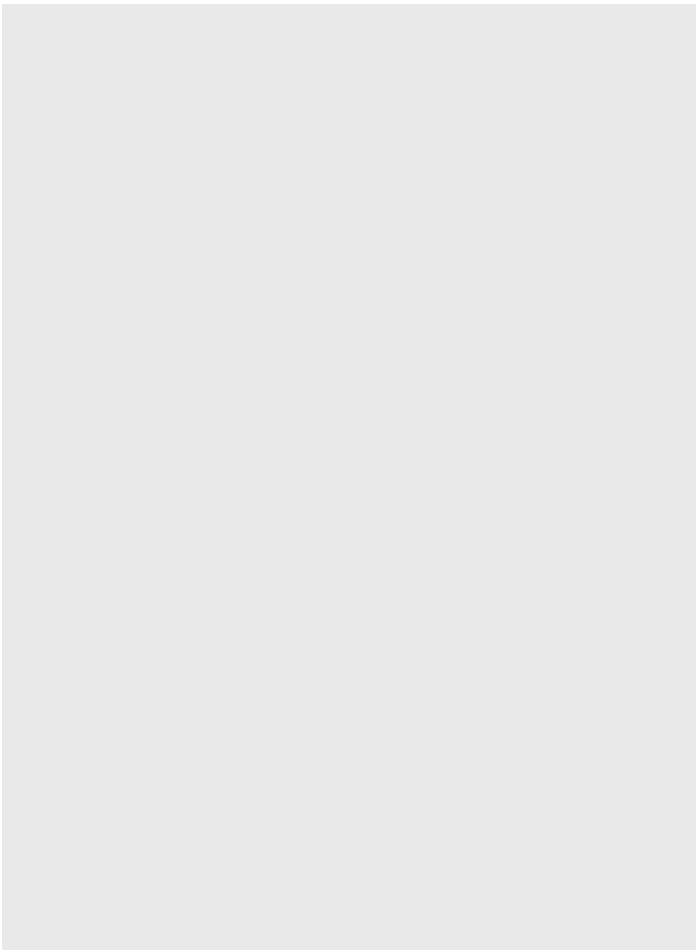

Restaurant Update

The Town of Webster continues to move forward with the plans for a restaurant at Sandbar Park. As we enter a critical point in the process, this issue of the Webster Today provides an opportunity to share an updated with ALL of Webster citizens.

At the June 13, 2024 Town Board Workshop, the Town introduced The Fantauzzo Family Brands as the restaurant operator of the future 2400 square foot restaurant. At this workshop, the vision and design of the restaurant was shared with the Town Board and the public. The June 13th workshop was the culmination of many months of design meetings required to create a vision that met both the needs of Fantauzzo Family Brands as well as the citizens committee. This citizens committee was created to provide feedback to the Town on aspects they believed were vital to any restaurant operation at the proposed Sandbar Park location.

Since June 13th, the Town of Webster - along with Campus Construction and Passero Associates have worked together to develop a set of bid specifications for the municipal bid process which must be followed for this type of project. During the bid process the cost for a restaurant structure as currently designed will be known. The bid process will begin October and typically lasts 3-4 weeks. During this time, potential contractors will submit their cost estimates for the building of the restaurant.

The location (shoreline of Irondequoit Bay) and design (2nd floor rooftop seating) of the 2400 square foot restaurant has been challenging, however the result is something that “checks all the boxes” for the vision of the restaurant. Additionally, Town has begun discussions with Fantauzzo representatives on how the future required public/private bond will be paid back through monthly “rent”. Once the bid process is completed and actual costs are known all parties involved will be able to work together to complete a finalized agreement.



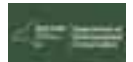
Above: 2 proposed renderings of Webster Sandbar Restaurant provided by Passero Associates.

The Town will continue to provide updates on the process as we move forward. We thank you all for your support on this project.

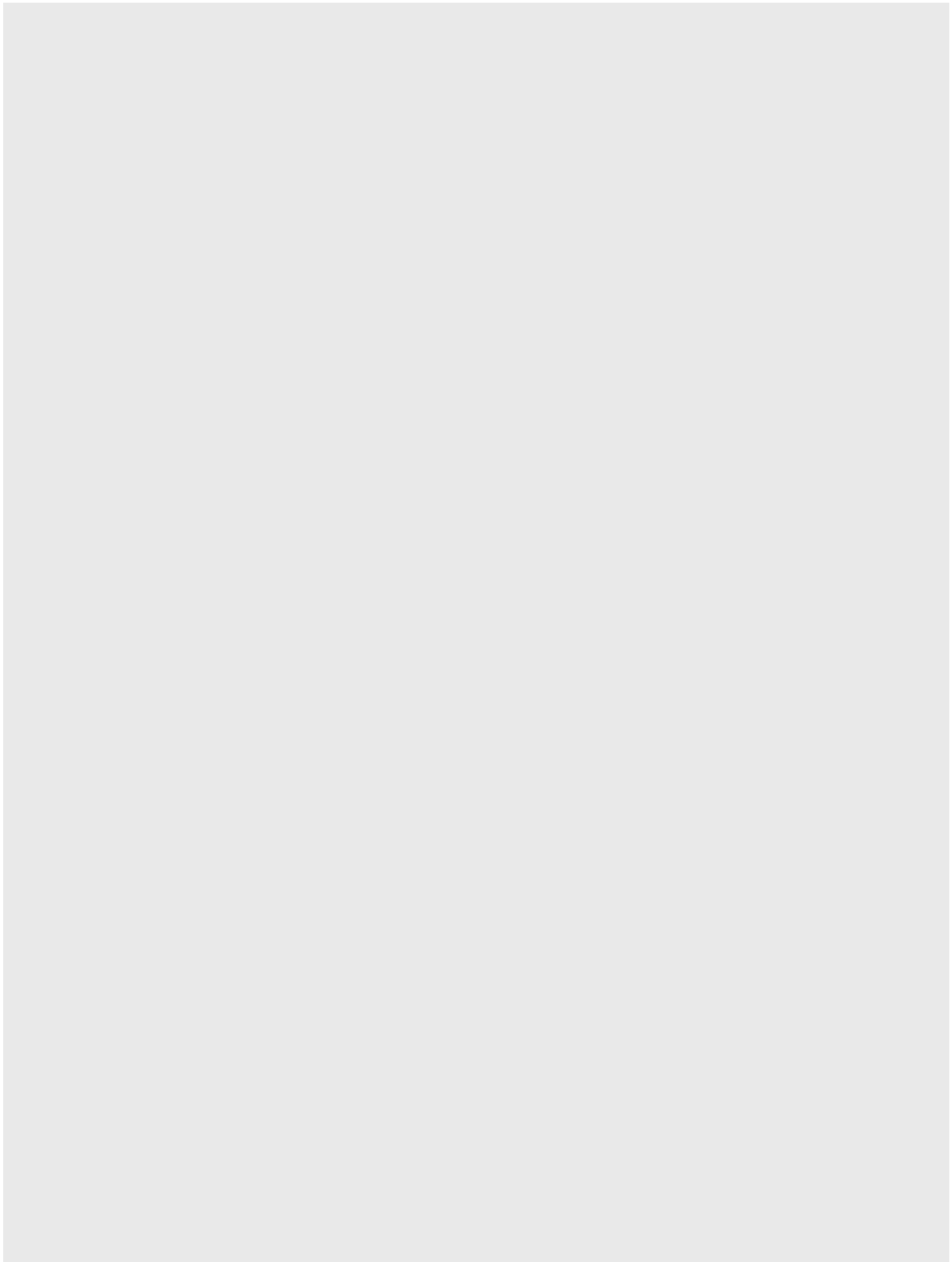

INFRASTRUCTURE INVESTMENTS:

Webster's Sewer Upgrades

Construction has steadily continued on the improvements being made to Webster's Wastewater Treatment Plant. Among these improvements includes the construction of a new digester, a high strength organic waste building, expansion of the administration building, and many other improvements necessary delivery sanitary sewage treatment services.

History of Wastewater Treatment in Webster

In the early 1990s, over twenty municipalities in Monroe County decided to close down their wastewater treatment plants and transfer residential and business sanitary sewer treatment to Monroe County Pure Waters. Within this move, the municipality would still be in control of the collection system in their town/village (i.e. sewer mains, pump stations, etc.). At that time, three municipalities opted not to transfer treatment to Monroe County Pure Waters: the Village of Honeoye Falls, the Village of Webster, and the Town of Webster.

Since 1990, interesting trends can be seen in the sewer rate, which have led to the sewer fund building minimal

reserves over 30 years. In 1990, the sewer rate totaled \$213.62, and the Town of Webster did not exceed this rate until 33 years later, in 2023 when the rate was \$231.97. In 1998, the sewer rate was \$167.80, and was \$167.50 in 2018, meaning the rate dropped \$0.30 over twenty years. While on the surface a lower sewer rate may have seemed advantageous, it left the sewer reserves low and unable to accommodate necessary improvements to the Town's sewer infrastructure. In turn, this has necessitated the Town of Webster making much-needed upgrades to sewer infrastructure.

Benefits of a Water Resource Recovery Facility

In 2018, Webster's wastewater treatment plant had over \$200,000 of "other revenue" from receiving septage from outside companies. Unfortunately, between 2019-2024, revenue number went down to zero annually as a result of the plant being cited for deficiencies by the New York State DEC. Part of the technological advances of the \$87.3 million new plant is the ability to take in septage from outside companies. It is estimated that in 2025 that will create \$110,000 of new revenue and

\$650,000 in 2026 and beyond. The plant will also be able to take in High Strength Organic Waste (HSOW). The revenue from HSOW is estimated at \$80,000 for 2025, \$1.1 million for 2026, and \$1.6 million per year thereafter.

Cost savings are another benefit of the upgrades being made to Webster's wastewater treatment plant. Sanitary sewer treatment is essentially about separating the solids and other stuff and leaving water that can be discharged into Lake Ontario. The solids left from this process (i.e. sludge) must be disposed of and hauled to landfills that take such waste. By the late 2010s, landfills were hitting capacity and closing, and not many new ones were opening, resulting in greater sludge hauling distance with fewer landfills. The cost per ton to haul sludge increased for the town from approximately \$250,000 to \$500,000 annually.

Part of the new technology at the plant is to dry out the "sludge" to the point where it is a pellet like fertilizer to be either sold, given away, or greatly reduced tonnage to be disposed of. While we do not yet have an exact number for cost savings due to this, what we do know is we have

protected the town from this supply-demand risk on sludge hauling costs by essentially eliminating traditional sludge production.

The Impact of fairlife®

One of the characteristics of Webster that made it an attractive location to Coca-Cola/fairlife® was the investments that were being put into the wastewater treatment plant. The water resource recovery project and fairlife®'s establishment in the Town of Webster have been closely tied to for a number of reasons.

One of these reasons is the one-time tie-in fee. When a new house or business/industry ties into the Town's sanitary sewer system it pays a one-time \$1,000/EDU fee to do so. Over the past eight (8) years (2017-2024), the average annual one-time tie-in fee revenue has been under \$100,000. Coca-Cola/fairlife® is paying the Town a \$21 million+ one-time tie-in fee and the Town has negotiated a contract with Coca-Cola/fairlife® to have that paid over 10 years, 2025-2034 at \$2.1 million per year.

Another factor is the flow that is expected from fairlife®. fairlife®'s flow as a large industrial user will increase the users the plant sees annually in a significant way. As mentioned before, revenue from HSOW is estimated at \$80,000 for 2025, \$1.1 million for 2026, and \$1.6 million per year thereafter. But why is HSOW revenue expected to jump so drastically between now and 2026? HSOW revenue will be made up mainly of fairlife®'s process by-product. The Town is projecting to have flow from fairlife® and possibly process by-product in 2025, but budgeted conservatively, therefore any flow/revenue we receive from fairlife® is a bonus to the sewer fund.

The final tie between fairlife® and the water resource recovery project is a \$20 million grant received by the Town. At the April 18 fairlife® groundbreaking ceremony, Governor Kathy Hochul announced that the Town of Webster had been successful in our application for this grant.

While the project would have paid for itself without the grant being awarded, this would have made it very difficult to stay under the New York State tax cap for 2025. The \$20 million grant saves the Town of Webster \$1.2 million of principal and interest payments for each of the next 30 years, resulting in an impact valuing at least \$36 million to the Town.

Protecting Taxpayers

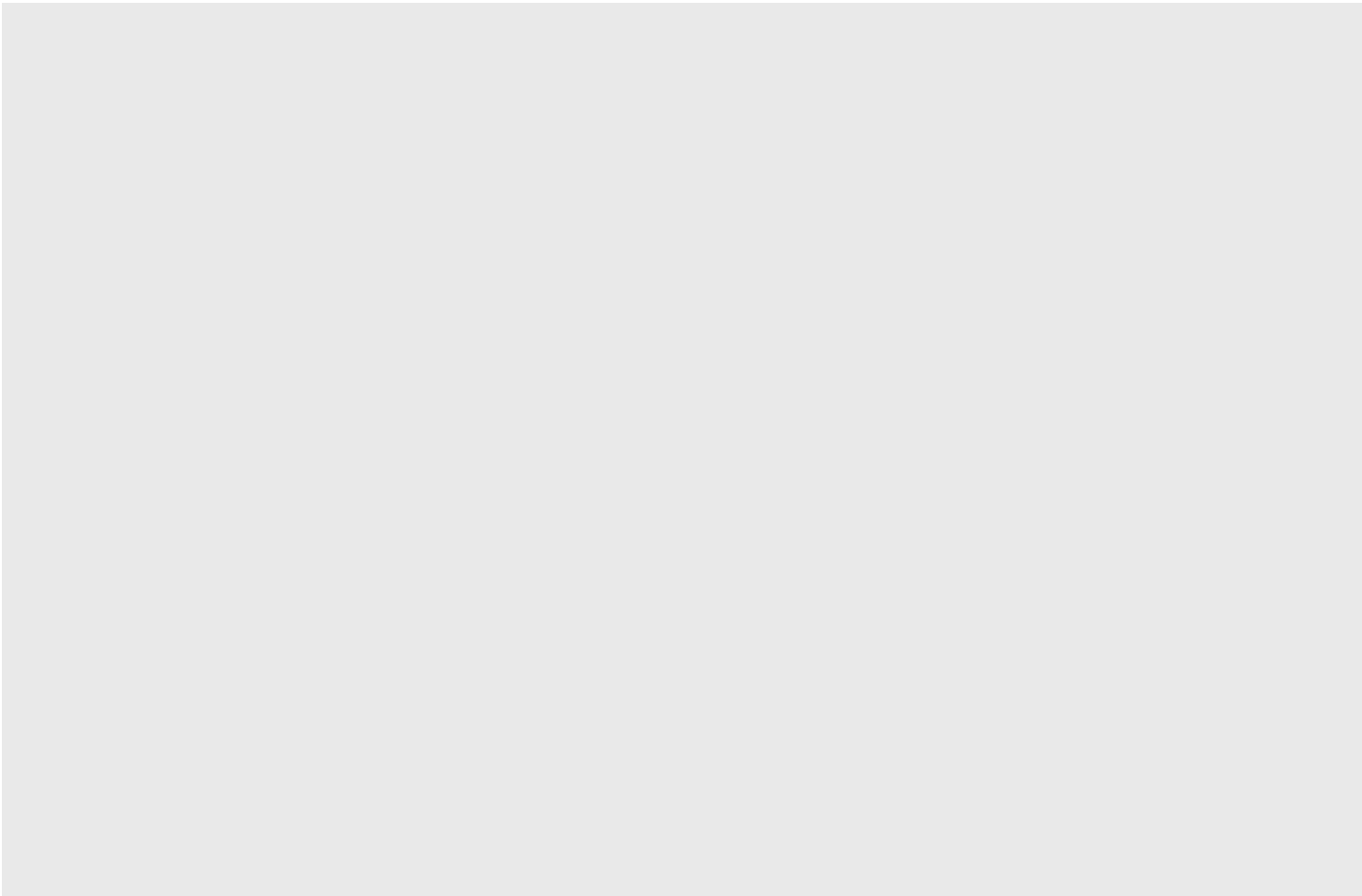
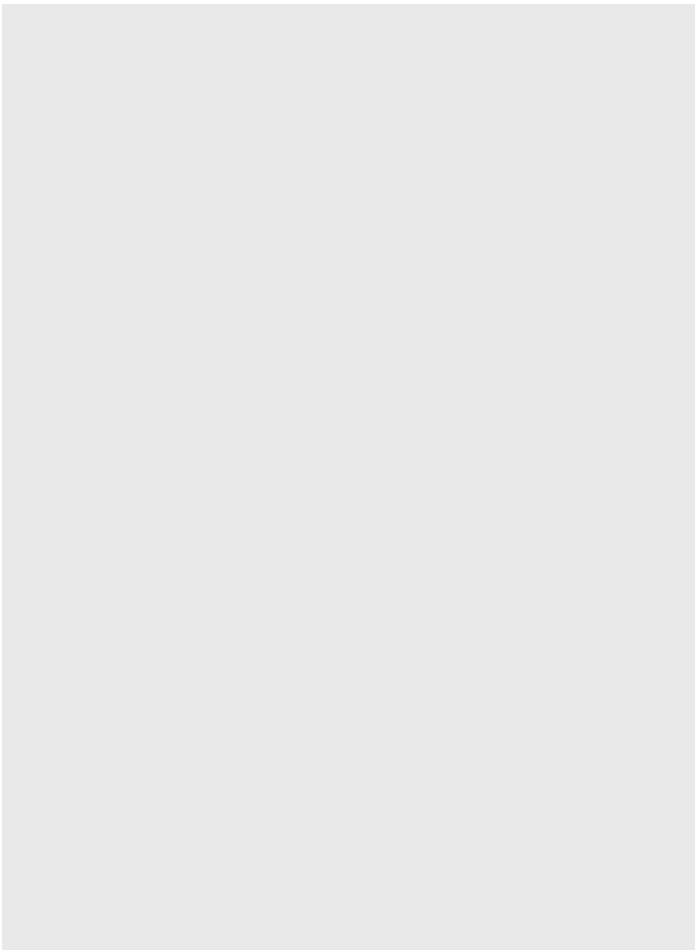
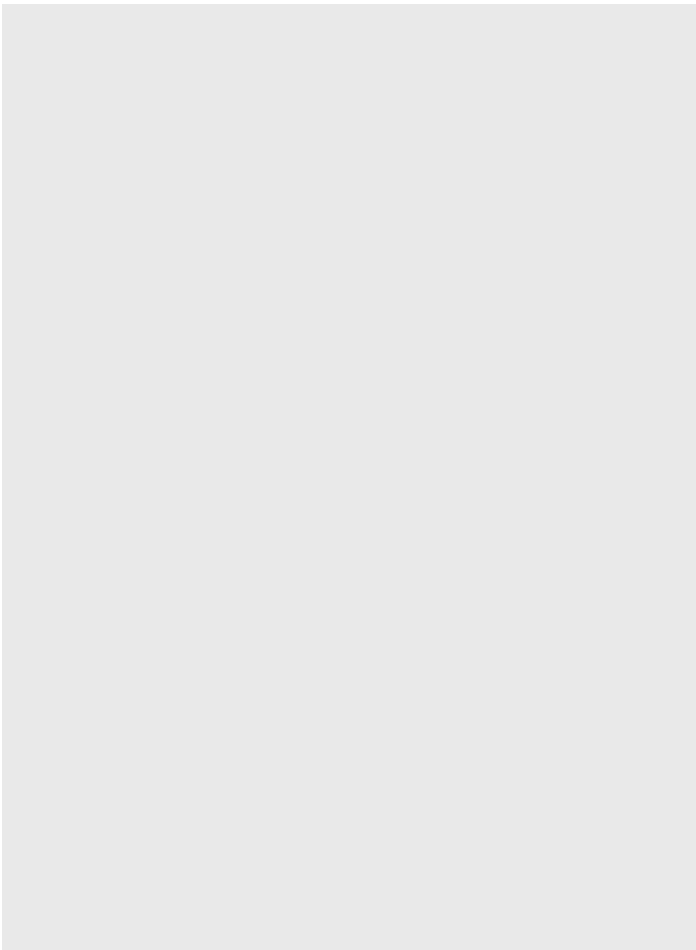
The impact of these investments on taxpayers equates to good news: taxpayers will see lower costs being spread across more users. You may wonder how this is possible with such a significant investment being made into the establishment of a water resource recovery facility. The answer lies in a combination of factors related to net costs declining and the total number of users increasing.

The net costs will be primarily influenced by Coca-Cola/fairlife®'s flow revenue, the cost savings through the sludge hauling process, and the additional revenue generated from taking in septage from outside companies, as well as the ability to process HSOW. The total number of users will go from 17,000 in 2024 to 25,000-29,000 in 2026 when fairlife® has three production lines operating in 2026.

In addition, the 2024 Town Board is adamant about not repeating past mistakes of 1990-2020 and failing to build reserves. Therefore, the 2025 budget has provisions for the funding of the sewer capital reserve account. The Town will be able to fund capital projects with reserve funds minimizing the amount needed to borrow.

At the September 5, Town Board Meeting a resolution adopted the tentative 2025 Town Budget that has the following three (3) components: 1. it is under the 2% New York State tax cap, 2. it has a \$253 EDU charge for sewer users which is \$43 less than 2024 charge, and 3. \$540,000 will be put into reserve for future sewer plant repairs and asset renewal.

This project has been underway for approximately one year. Project leaders are targeting July 2025 for the acceptance of septage and HSOW and September 2025 for the start up of the biosolids dryer. In September 2025, the plant is anticipated to be prepared to accept waste flow from the fairlife® facility.

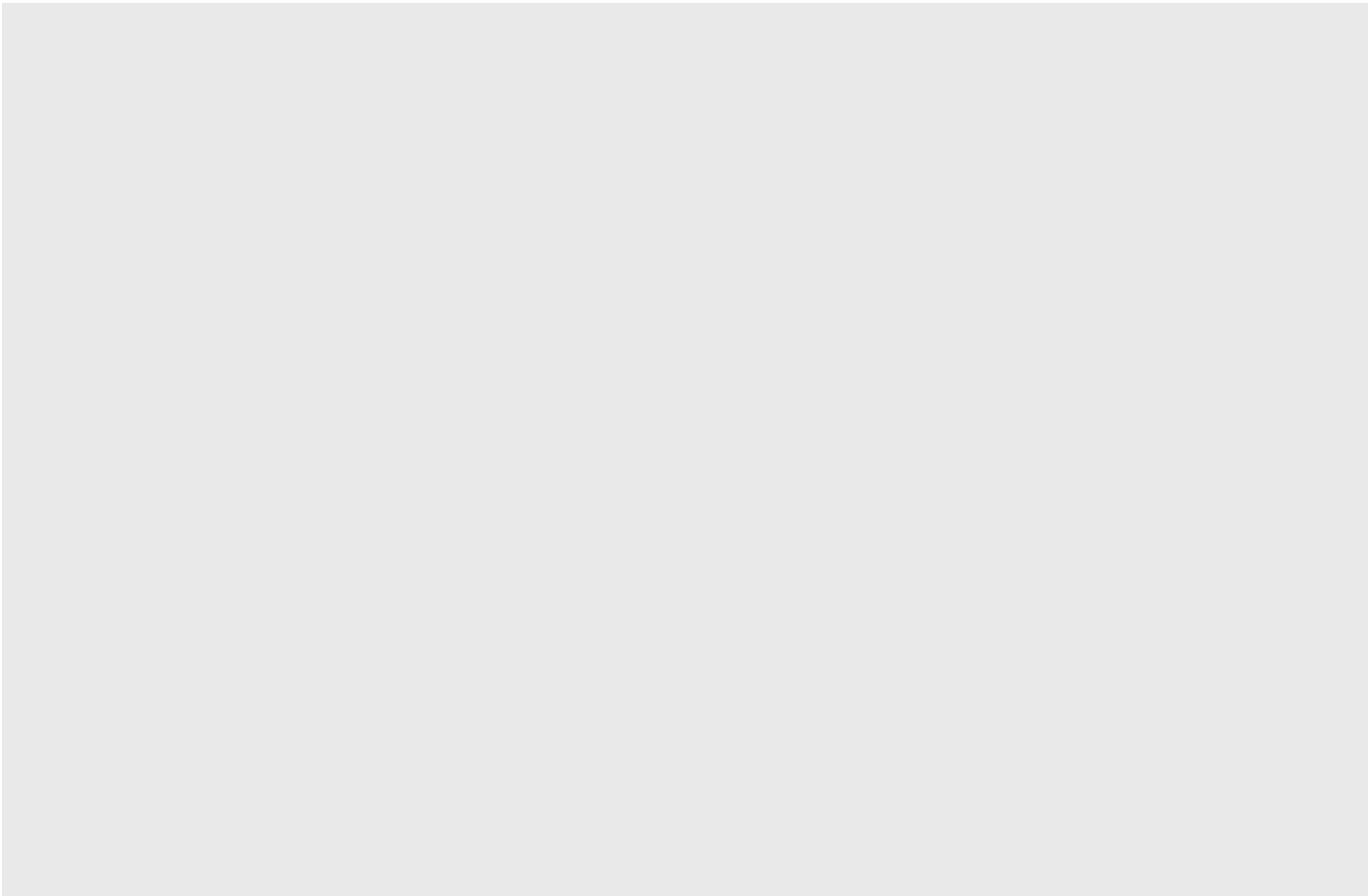
